Fees for Mt. Lebanon residents are as follows:

Sessions 1 and 2: No Charge
 Sessions 3 through 10: \$20.00/session
 Sessions 11 and beyond: \$50.00/session

Fees for those residing outside of Mt. Lebanon:

All sessions: \$50.00/session

The industry standard fee for counseling services is \$80 - \$120/session. Outreach's low fee of \$50/session is made possible by foundation grants and other funding received by Outreach.

However, if there is a financial hardship and further financial assistance is required, a sliding scale fee is available for individuals who are eligible. These fees will only be applied to the following clients:

- a. Mt. Lebanon residents who have reached their 3rd session and beyond
- b. Non Mt. Lebanon residents starting with their first session.

In accordance with Outreach Teen and Family Services' Subsidized Counseling Policy B10, the Federal Poverty Income Guide is utilized for approving subsidized counseling services and sliding fees.

Eligibility is dependent on family size.
